This report provides a comprehensive overview of the social determinants of health that influence health outcomes in cancer care and promising practices that advance equity. In 2018, the National Comprehensive Cancer Network conducted a year-long environmental scan to identify challenges and opportunities to advance equity in cancer care. In December 2018, NCCN hosted a Patient Advocacy Summit on this topic. This article summarizes the findings of the study and the Summit. Provides an overview of health inequities and promising practices to address barriers to equitable cancer care. The article includes insights from a patient advocate perspective, as well as a case study of the socioeconomic needs of Navajo patients that affect health outcomes. The paper identifies achievements from patient advocacy groups that have improved care for specific target populations and areas for future initiatives. Provides background information and would be useful to use this paper with another tool to identify areas for improvement within a practice setting.
